PAST EVENTS

Remembrance Day, November 19, Gettysburg, PA.

The unit closed out its 2005 activities with a trip to Gettysburg for Remembrance Day. This year, instead of marching in the parade and then going to our unit monument, we participated in the 3rd annual Memorial March, sponsored by the Living History Guild of Elmira, NY. started from the famous Peach Orchard on the Emmittsburg Road, at 10:00. The column of 25 participants made stops at the monuments to the 2nd NH, 86th NY, 116th PA, 5th NH, 12th US, 1st PA Reserves, 83rdPA, 2nd RI, and 1st MN. At each stop a brief narrative of the unit's service was read and a wreath & flag placed. Support for the program was supplied by the ladies of the LHG and our own Kim Sebestyen, who provided us with an excellent lunch on the north slope of Little Round Top.

Following the end of the march at 2:00, we regrouped at the gatehouse of Evergreen Cemetery for a visit to the graves of Marcus Past and William Allen of Company D, who lie in the soldiers section of the cemetery. Following this we proceeded to the Minnesota plot in the National Cemetery where letters from 1st Sgt. James Wright and Lt. Col. Charles Adams were read and honors rendered.

After visiting the sutlers and drinks at the Holiday Inn bar, we gathered for dinner in the Abigail Adams room of the Dobbin House, where we were joined by Donna Nangle and Nic & Kate Ellis. After a delicious dinner and much conversation, we adjourned to our homes or various evening entertainments.

Payne's Farm

Event report from Carter Bertone

On the afternoon of November 28, soldiers of the 151st New York Infantry began to assemble about 5 miles south of Payne's farm. The Regimental Color Sergeant immediately posted pickets, and began issuing rations in preparation for the anticipated march north. The 151st settled in for a cold night where the temperatures dropped into the upper 30's. The only action that night consisted of our pickets driving off an inebriated civilian who demanded entry to the camp.

Reveille was sounded promptly at 6AM on the 29th and the men commenced morning fatigue duty. After several hours of drill, the regiment began the march north buoyed by the martial strains of the regimental band. After nearly three miles, the Regiment halted in a grassy field about one mile from our planned destination. After an hour or so we continued the march. Upon arriving at our destination we were quickly formed behind a row of trees overlooking a large field.

Soon after arriving we came under fire from rebel forces concealed in the woods opposite our position. Our commander immediately deployed skirmishers and returned the enemy fire. Though they put up a gallant fight, our skirmish line was driven back and the regiment was rushed forward to engage the enemy force that was advancing to our front. The battle raged between our two lines for over an hour, and our casualties soon began to mount up as our ammunition supply was quickly diminished.

Realizing our force was running short of ammunition and dark was quickly approaching our commander ordered us to pull back to establish a defensive position. Pickets where sent out and soon parties were sent forward to retrieve our wounded comrades. Once brought back to camp, the

wounded where treated by the Regimental Surgeon and his assistants. They where made as comfortable as possible as the night settled in. Once again, the night was unbearably cold. Our shivering soldiers awoke early on Sunday and where marched back on to the field of battle to participate in a ceremony recognizing the organizers of the weekend's activities and commemorating those soldiers who fought and died in the actual battle. A great time was had by all that participated.


Civil War Historian
